

Under the UGX 1Bn allocation for FY 2023/24 to the road sector in the district, 855m has been allocated to three roads which are currently being worked on and the works include heavy grading, full gravelling, swamp raising which will involve drainage improvement, and culvert installation.

Ocorimongin road – Abule road



In Ocorimongin – Abule road engineers are doing full gravelling covering a distance of 8kms. Murrum was dumped and so far 7 kms are covered with gravel and actual spreading and compacting done.

Koritok – Aparia road



On Koritok-Aparia road the works being undertaken are full gravel, culvert installation and construction of head walls for the culverts. This covers 7.5Kms and 6Kms of full gravel, with 19 culverts installed out 24 with headwalls.

Kaberamaido District Acquires Fiber Glass Boat to **Combat Illegal Fishing**

Mr. Agaja Joseph, has acquired a plastic Fiberglass Boat valued at UGX 39,000,000. This acquisition from the Fisheries Institute in Entebbe aims to enhance surveillance capabilities against illegal fishing activities plaguing the various landing sites within the district.

During the boat's official commissioning, LCV Chairperson Victor Rex Ekesu expressed gratitude towards the Fisheries Department for prioritizing the procurement of the vessel in their strategic plan. Ekesu emphasized that with proper awareness campaigns and adherence to sustainable fishing practices, Okile landing site, formerly known as Kele Port, can reclaim its former prosperity.

Encouraging the community to shift focus from the absence of industrial facilities within the district, Ekesu highlighted the abundant natural resources bestowed upon them. He highlighted witchcraft and jealousy.

Kaberamaido District: Rehabilitation Works Commence with Acamidako-Apai Rd , 19 Other Roads to Follow

Kaberamaido District officials, led by RDC Lotem Linos Tumkori, have kicked off the rehabilitation of the Acamidako-Apai Road in Swagere Parish, Ochero Sub-county.

The 8 km road is set to undergo improvements at a cost of UGX 52,634,600. This project is part of the district's plan to revamp a total of 19 roads using the UGX 1 billion road grant allocated by the government to each district for the fiscal year 2023/2024.

During the launch, RDC Tumkori emphasized the importance of community oversight to ensure the project's success and accountability. To encourage vigilance, he announced a reward of UGX 200,000 for reporting any illicit activities related to the project like fuel syphoning or selling of murram. He however cautioned the community against false accusations.

Addressing the community, LCV Chaiperson Victor Rex Ekesu expressed gratitude for prioritizing the Acamidako-Apai Road, emphasizing its significance to local farmers who have struggled due to the road's poor condition since its last maintenance in 2008.

CAO Ddamba Henry highlighted transparency and accountability as central goals of the project, underlining that the community has a right to understand the project scope to ensure that resources are used effectively.

Senior Engineer Ewayu Francis outlined the rehabilitation plan, including bush clearing, culvert covers, reshaping, culvert installations, and the placement of informational billboards. He advised against using Ox-Ploughs on the road to prevent erosion, recommending transportation by bicycle to safeguard the road's integrity.

AMURIA: Gov't Launches Construction of Two Seed Secondary Schools

Expanding Access to Affordable Education in Local Communities

muria district has taken a significant step forward in enhancing education accessibility for its residents with the launch of construction of two seed secondary schools.

These seed secondary schools aim to provide more affordable secondary education to the people of Amuria, aligning with the government's commitment to establish a secondary school in every sub-county.

The newly initiated projects are the Amolo Seed Secondary School and the Apeduru Seed Secondary School, which will be developed in phases to accommodate the educational needs of the region.

The initial phase of constructing Amolo Seed Secondary School has been assigned to CAB Uganda Limited at a cost of UGX 664,860,600, while the contract for Apeduru Seed Secondary School has been granted to BP Enterprises and Construction Company Limited for UGX 684,200,000.

These additions bring the total number of seed secondary schools in Amuria to five others which include Wera Seed Secondary School, Asamuk Seed Secondary School, and Morungatuny Seed Secondary School.

During the launch of Amolo Seed Secondary School, Minister of State for Works, Musa Ecweru (Amuria County MP), emphasized the government's unwavering commitment to ensuring that every sub-county across the nation has a Seed Secondary School.

"Our party the National Resistance Movement Party that you always vote for is the one that is bringing education closer to you so that your children do not trek long distances in search of education," said Minister Ecweru.

Acting Sub-county Chief of Amolo, Job Okiring also noted that these schools will significantly reduce the burden on learners who previously had to travel long distances for education. He pointed out that nearby schools were approximately seven kilometers away, which is a challenging journey for students.



Soroti: Modern Science Laboratory and ICT Library **Construction Launched at Dakabela Comprehensive SS**

The the Ministry of Education and Sports, has earmarked UGX 760 million for the construction of essential infrastructure at Dakabela Comprehensive Secondary School in Soroti District under the Uganda Intergovernmental Fiscal Transfers Program (UgIFT).

This funding, as explained by District Education Officer Mr. James Oede, will facilitate the development of a state-of-theart Science Laboratory catering to Chemistry, Biology, and Physics, alongside an ICT library. Additionally, provisions include a 5-stance drainable pit latrine for learners, a 2-stance counterpart for staff, and a sports field.

The site was handed over to Ms Arcadian Construction and Alps Group as the constructor.

Dakabela Comprehensive Secondary School, established by the community, is progressively transitioning into full government oversight, marking a significant educational development in the region.

Uganda Partners with FAO and China to Introduce **Innovative Rice-Fish Production Initiative** in Soroti District

Uganda has joined forces with the Food and working through local governments across 39 Agriculture Organization of the United Nations (FAO) and China to introduce a revolutionary high-yielding and climate-smart rice-fish production initiative in Soroti district.

The collaboration, known as China-Uganda South to South Cooperation, facilitated by the Ministry of Agriculture, Animal Industry and Fisheries (MAAIF), in conjunction with the Chinese firm Shanghai Agro-Biological Gene Centre (SAGC), aims to enhance farmers' productivity in the region.

Dr. Charles Owach, Assistant Country Representative for FAO, highlighted that Phase III of this initiative, running from 2022 to 2025, is a flagship project jointly financed by FAO and China. The Government of Uganda,

districts including Soroti, will spearhead the implementation.

Under this cooperative venture, various enterprises such as fish, rice, poultry, goats, and value addition will be pursued to ensure food security, increased agricultural output, and boosted incomes within participating communities.


The introduction of the Rice-fish culture technology from China in Soroti marks a significant milestone. Selected as one of the ten districts for Phase III, Soroti will benefit from the cultivation of rice varieties WDR73 and PR107, yielding 1kg and 0.8kg per square meter respectively. These yields are expected to surpass current production rates by two to three times.

To ensure sustainability, active involvement of the private sector is encouraged in nurturing these seeds.

Joseph Opus, Senior Fisheries Officer, emphasized the importance of marketing within the livestock and crop enterprises being implemented. He urged the Soroti community to embrace fish farming as a profitable business venture offering financial rewards, food security, and improved nutrition.



Seven Arrested for **Extortion from PDM** Applicants in Kapelebyong, Ordered to Refund

The seven board members of Amootom 13, 2024. Parish SACCO in Okungur Sub been arrested for extortion of money from applicants of Parish Revolving Funds under Parish Development Model, have begun making refund.

The individuals involved in this scandalous act are as follows: Ogwang Silver - Board Chairperson, Akulo Maragaret - Board Secretary, Acham Sarah - Treasurer, Opiding Moses - Chairperson loans, Emitu Charles - Secretary loans, Akiyai Beatrice - Treasurer loans, and Ekanya Simon -Chairperson supervisory committee.

Reports indicate that approximately shs1.8m was unlawfully obtained from 55 applicants, leading to their arrest on May 20, 2024. Following their confession of soliciting money under the guise of operational fees, the perpetrators initiated the refund process. A total sum of Sh1,297,000 was returned to applicants in an installment on June launched a comprehensive inquiry, officially

County, Kapelebyong District who had According to James Collins Epiu, the Senior Commercial Officer in Kapelebyong District, 47 applicants received a refund of Sh25,000 each, five applicants received Sh20,000 each, and one applicant was reimbursed with Sh21,000. Two board members who are reportedly encountering difficulties in the refund process have been given until mid-July to fulfill their obligations.

> Tom Otukol, the Resident District Commissioner(RDC) for Kapelebyong, issued a stern warning to the board members, cautioning them against future breaches of established guidelines and loan policies.

> "I have observed that these boards have capacity building gaps. They need additional training to avoid falling into problems," Otukol said. In response to these alarming events, the Police at Kapelebyong Central Police station have

documented under file reference GEF-003/2024 implicating the suspects.

These illicit activities directly violate Section 3, subsection 3.6 of the PDM User Handbook from October 2022, as well as section 2.2c of the loans policy. The loans policy explicitly states that the board is only permitted to collect a maximum of shs5,000 from beneficiaries as a loan application fee.

The saga serves as a stark reminder of the importance of transparency, accountability, and adherence to set guidelines within the framework of developmental initiatives.

Katakwi District Gears Up for Phase Two of Parish Development Model Implementation

atakwi district's local government is poised to initiate the second phase of the Parish Development Model (PDM). The PDM, a government-backed initiative aimed at empowering local communities, has made significant strides in its initial phase, setting the stage for further progress and impact.

Since the commencement of the Establishment phase on June 22, 2023, a total of UGX 11,674,100,000 from the Parish Revolving Funds (PRF) has been disbursed to 11,683 eligible households across 109 PDM SACCOs in all 20 Sub Counties and Town Councils. This represents a remarkable disbursement rate of 99.5%, signaling a strong commitment to the program's objectives.

The recent allocation of UGX 5,450,000,000 - constituting 50% of the PRF for the fiscal year 2023/24 - earmarked for 109 PDM SACCOs under the forthcoming Establishment phase 2, underscores the government's continued support for grassroots development initiatives. An additional UGX 27,250,000 has been provided to cover administrative costs associated with processing PRF disbursements, further optimizing the program's efficiency.

Preparatory activities are already in motion, with the 109 PDM SACCOs actively engaged in vetting eligible beneficiaries through community meetings. Beneficiaries will receive more training on various essential topics including agronomic practices, animal husbandry, business planning, and group dynamics, facilitated by Community Development Officers (CDOs) and Sub County Production Extension staff.

Despite the program's successes, challenges persist, notably regarding the expectations of non-subsistence beneficiaries and issues surrounding data processing within the PDM Information System (PDMIS) - Financial Inclusion System (FIS). Concerns have also been raised regarding the misuse of PRF funds, with instances of diversion towards non-productive ventures outside the program's recommended enterprises.

Mr. Todi Patrick, the District Commercial Officer, commended the dedicated team for their accomplishments and highlighted the need for a holistic approach to activate all six PDM Pillars urgently.

Katakwi District Commissions Six Boreholes to Improve Water Access

Katakwi marked the commissioning newly constructed of six boreholes. The initiative, which was part of the water sector's activities for Financial Year 2023/2024, aimed to address the crucial need for reliable water sources in various communities within the district.

The contract for drilling, casting, and installing the boreholes was awarded to MAMA Borehole Wells Ltd., a company recognized for its expertise in constructing water infrastructure projects.

These boreholes were i strategically located in Ogangai and Omasai in Okulonyo Sub County, Ogugut in Okore Sub County, Aperit Isiru in Magoro Sub County, and Aloet in Angodingod Sub County. The total project cost was covered under the District Water and Sanitation Conditional Grant, amounting to approximately 141 million shillings.

The official commissioning In their speeches, district ceremony took place on the officials 18th of June 2024 at Apolin village in Katakwi Sub County. The event was attended by key figures including the District Water Officer, district improving their well-being. leadership, Deputy Resident Chairperson, Ag. PAS, technical Omolo told the community. staff, and representatives from various sub-countries. Katakwi District boasts a network of water infrastructure, including 34 valley tanks, 10 valley dams, 600 boreholes, and 3 motorized boreholes in key locations. Kumi District: Delving into the **Authors of Nyero Rock Paintings**



A rock boulder with painted symbols at Nyero 2. Clearly seen are a boat, fertility symbols, concentric cycles and other enigmatic symbols.

The Nyero Rock paintings, located approximately 8 kilometers west of Kumi town along the Kumi-Ngora road within Nyero Town Council, are the oldest rock paintings and the first to be discovered in Uganda. They hold a significant place in Uganda's historical heritage and are the most popular historical sites in the country.

The rocks are considered sacred ancestral places, where generations past would journey

inhabitants.

Although it is widely agreed that the paintings were created during the late Stone Age era, the original authors of the paintings have been the subject of much debate among researchers and archeologists. However, archeological excavations at the sites found typical Late Stone Age artifacts alongside pottery, suggesting possible interactions with Neolithic

develop specialized tools like bone harpoons for fishing. Symbolism was significant in their culture, evident through body ornaments, the use of ochre, and the presence of rock art.

While the exact genetic and linguistic origins of the authors of the paintings are challenging to ascertain, a section of archaeologists believe that the paintings were likely the work of the Twa hunter-gatherer communities, believed to communities (Lawrance 1953; Harwich 1961; have inhabited the area during the late Stone Age period. The reason they give is that the paintings here match the distribution of the ELate Stone Age hunter-gatherer culture, whose works are equivalently found spread across the east and central parts of Africa. The Twa pygmies can currently be found in the eastern Democratic Republic of Congo and western Uganda, along the Congo-Rwanda border.

of the paintings, given that many of the known rock art sites in Uganda are located in northeastern Uganda, where the Iteso and the wider Ateker ethnic group reside.

This differing opinion is also grounded in oral traditions and the works of researchers like Posnansky and Nelson (1968: 157), who argued that there was no known occupation of the Nyero rock shelters until the arrival of the Iteso. The Iteso Welfare Association also highlights that Iteso migrated to Teso over a period of six generations. The first generation (Ojurata's tadpoles) were short people who were mainly gatherers and hunters.

Interestingly, some of the depictions at Nyero Rock, such as those of rain-making ceremonies, resonate with the ethos and culture of the Iteso people. These ceremonies were performed to invoke the intervention of a higher power for rain during periods of drought. A.C.A. Wright, for example, documented a rain- Regardless of the exact creators of the

in 1940 in Kyere Rock, not so far away from Nyero Rock paintings. A recent rain-making ceremony by Iteso from Amuria was even recorded in the drought of 2016 (The Daily Monitor, Friday, July 29, 2016).

Similarly, depictions of the sun, a ladder, a boat, drought, and plagues at these sites have been interpreted by oral traditions to signify the practices, challenges, and hurdles overcome by Iteso while migrating to the present-day Teso sub-region. It is important to note that Iteso trace their origins back to Egypt, a country where the worship of the sun god was prevalent in ancient times. It is there that they also witnessed drought and different plagues, including the infestation of flies during the deliverance of the Israelites from the pharaoh. This may partly explain the symbolism of the rock art at Nyero and other sites across northeastern Uganda.
